## RELEASE AND WAIVER

**WAIVER.** I, the undersigned, have voluntarily enrolled \_\_\_\_\_, my child, a minor, in a futsal, soccer, or other sports program offered by RIO 40 LLC, which will include, but may not be limited to, running, aerobic conditioning, cardiovascular conditioning, kicking, agility exercises, contact with other players, and team training (collectively, "RIO 40 Program"). In consideration of my participation in any RIO 40 Program, I, on behalf of myself, my heirs, administrators, successors and assigns, hereby forever release and discharge and hereby hold harmless RIO 40 LLC, and its managers, members, employees, trainers, partners, agents, contractors, sub-contractors, representatives, sponsors, volunteers, instructors, heirs, successors and assigns (collectively, "RIO 40"), from any and all claims, demands, damages, liabilities, expenses, rights of action or causes of action, present or future, arising out of or connected with my child's participation in this or any program offered by RIO 40, including any injuries resulting therefrom. This waiver and release of liability includes, without limitation, injuries which may occur as a result of (i) my child's participation in any RIO 40 Program; (ii) my use of all amenities, practice facilities, courts, pitches, and equipment utilized in any RIO 40 Program; and (iii) negligence, fault or carelessness of RIO 40. By signing this waiver and release, I fully intend to discharge RIO 40 from any and all injuries or losses suffered by my child while participating in any RIO 40 Program.

**Assumption of Risk.** I recognize that sports programs might be difficult and strenuous and that there could be dangers inherent in exercise for some individuals, including my child. I recognize that some of the RIO 40 Programs may be offered outside and I understand the risks associated with exercising outside, including but not limited to weather, road, and traffic conditions, and uneven exercise surfaces. To the best of my knowledge my child is in good physical condition and has no illness, physical limitation, health concern or injury that would be aggravated, would be the cause of any injury sustained, before, during or as a result of his/her participating in a RIO 40 Program, or that would prevent him/her from participating in a RIO 40 Program. I recognize that an examination by a physician should be obtained by all participants prior to involvement in any sports or exercise program. If I have chosen not to obtain a physician's permission for my child prior to beginning a program with RIO 40, I hereby agree that I am doing so at my own risk. In any event, I acknowledge and agree that I assume the risks associated with any and all activities and/or exercises in which my child participates. I acknowledge and agree that no warranties or representations have been made to me regarding the results my child will achieve from any RIO 40 Program.
